# CODE OF CONDUCT

## for suppliers of FAKRO group companies













The Code of Conduct applies to the following areas of supplier companies' activities:

- » Environmental responsibility
- » Respect for human rights and social responsibility
- » Ethics in business

We want to cooperate with suppliers who share our values. The expectations contained in this Code of Conduct influence our decision to establish or extend cooperation with the supplier concerned. In the event that the supplier fails to meet our expectations, we will consult with the supplier on the implementation of corrective actions and jointly build awareness and develop the principles of responsible business and sustainable development. In case the supplier does not join in the activities and does not strive for changes in his company aimed at improving issues related to responsible business and sustainable development, we will not continue our cooperation with that supplier.

The supplier will participate in the self-assessment survey at the request of FAKRO Group companies. The supplier will also enable an audit to be carried out by representatives of FAKRO Group company or another entity that will carry out such an audit on behalf of FAKRO Group companies. Upon request, the supplier will provide appropriate resources and documentation during the audit.



- » Compliance with waste management laws.
- » Minimise the generation of business-related waste.
- » Monitor wastewater and solid waste generated from operations, control and treat before discharge or disposal.
- » Eliminate or minimise chemicals and hazardous substances.









- » The supplier will respect the rights of his employees to form and join trade unions and collective bargaining without fear
- » The supplier does not accept workplace bullying.
- » The supplier will not tolerate any form of inhumane treatment
- » The supplier complies with health and safety regulations of the country in which he operates.
- » The supplier will provide safe and healthy working conditions by implementing health and safety procedures and systems to eliminate the risk of accidents at work.









### **ETHICS IN BUSINESS**

- » We do not tolerate any form of bribery or corruption by suppliers' employees.
- » We expect all participants in our supply chain to act fairly within the competition.
- » The supplier counteracts all forms of corruption and implements preventive practices and, in the event of any form of corruption, takes firm corrective actions.
- » The supplier protects all confidential information provided by FAKRO Group companies.

- » The supplier will not engage in activities that may impede the development of fair competition.
- » The supplier submits true and accurate tax returns to tax authorities.
- » The supplier will refrain from business contacts with countries, companies or individuals on which sanctions have been imposed.
- » The supplier applies ethical principles in all areas of his business.









Suppliers are obliged to read and understand the requirements of this Code, to act in accordance with the expectations set forth therein, and to ensure, as a necessary minimum, compliance with all laws, rules, regulations and standards applicable to their business.
